AGREEMENT

TERMS AND CONDITIONS

Reservation and Security Deposit (Due At Time Of Booking): \$250. This deposit is refundable after conclusion of the event and after a Lions Club representative inspects the facility and certifies the facility is clean, undamaged, and in an orderly condition.

Cleanup and Closing: Users will leave the facilities in a clean, undamaged and in an orderly condition. Any costs incurred by the Lions Club of Cambria to clean or repair the facility after the event will be deducted from the Reservation and Security Deposit. If costs of cleaning or repairing the facility exceed \$250, User will be billed the actual costs attributed to cleaning and repairing the Grounds from the event.

Cancellations: If the event is cancelled, all fees and deposits will be refunded less any direct costs incurred to prepare the grounds for the event.

Insurance: User must provide written proof of general liability insurance with a limit of not less than \$1,000,000 combined single limit. If alcohol is sold on the premises during the event, user must also provide liquor liability insurance with the same coverage limits as the general liability policy. The Lions Club of Cambria must be listed as an additional insured under all policies and valid Certificate(s) of Insurance must be submitted to the Lions Club of Cambria prior to the event.

Liquor License: If alcohol is served on the premises, a liquor license from the State of California Alcohol Beverage Control. A copy of the valid license must be submitted to the Lions Club of Cambria prior to the event and a copy must be prominently displayed on the premises during the event.

Event Publicity: Publicity or promotion of any event must not state or infer that the Lions Club of Cambria or Lions Clubs International sponsors or supports the event or activity, unless prior written permission is given by the Board of Directors of the Lions Club of Cambria.
